US FELLOWS COMMUNITY HEALTH SERVICE PROGRAM - THROUGH THE SCHWEITZER MENTORED LEADERSHIP DEVELOPMENT PROGRAM, SCHWEITZER FELLOWS PROVIDED APPROXIMATELY 40,000 HOURS OF SERVICE TO HELP AND EMPOWER MORE THAN 20,000 PEOPLE TO LIVE HEALTHIER LIVES. OVER THE PAST YEAR THEY WORKED IN OVER 150 COMMUNITY-BASED ORGANIZATIONS IN 14 LOCATIONS ACROSS THE COUNTRY. DURING THEIR FELLOWSHIP YEAR, THE FELLOWS GAINED VALUABLE EXPERIENCES THAT ENHANCED THEIR CAPACITY FOR LIFELONG WORK WITH VULNERABLE AND UNDERSERVED PEOPLE IN COMMUNITY SETTINGS
